Motion to support Ontario Southwest Tourism Relief Fund, funded by the Government of Canada through the Federal Economic Development Agency for Southern Ontario (FedDev Ontario), to provide support to tourism-dependent SMEs, not-for-profit organizations, municipalities, and Indigenous tourism operators (Ultimate Recipients). SWOTC will receive a total of \$7,000,000 to cover administration costs (up to 10%) and to provide non-repayable contributions of up to \$100,000 for up to 50% of eligible costs for for-profit businesses and up to 100% of eligible costs for not-for-profit organizations, to strategically adapt products and services to adjust to changing public health requirements while planning for, and investing in, recovery efforts for future growth.
